## ANNEX: GUIDANCE ON SUBMITTING AN APPLICATION TO USE NON-ORGANIC BEESWAX

The Regulation (EU) 2018/848 states that only organically produced beeswax shall be used for the production of organic products. However, it also allows the use of beeswax not obtained by the organic production method to be used under certain conditions.

A CERT needs to receive the derogation request **before** the purchase of the beeswax.

### **Conditions for derogation request**

---

In the case of new installations or during the conversion period, non-organic beeswax may be used only:

- a.** where beeswax from organic beekeeping is not available on the market;
- b.** where it is proven free of contamination with products or substances not authorized for organic production; and
- c.** provided that it comes from the cap.

### **Procedure for Getting Approval**

---

Getting approval to use non-organically produced beeswax requires justification from your side. Thus, you are obliged to follow the below procedure for getting such authorization:

1. Firstly, check the availability of organic beeswax in your Country's market.
2. These attempts must be documented (letters, emails, declarations, etc.) and submitted to A CERT along with the present application; minimum 3 attempts must be provided.
3. Submit the beeswax specifications from the selected supplier in a form of a signed declaration indicating whether the wax is coming from the cap or not.
4. The beeswax is proven free from contamination by substances not authorized for organic production. For this reason, a laboratory analysis, with an adequate scope of potential non-authorized substances, must be provided.
5. Submit the present Application to use non-organic beeswax along with the above documentation.

**Lastly, once the derogation is granted, you must submit to A CERT the invoice after the purchase of the authorized beeswax.**

**\*In case the above documentation is not in English, you are requested to submit the above documentation both in your language and in English.**
